The Nordic Social Pharmacy Conference and the Nordic Networking Group of Clinical Pharmacy Conference (NSPC&NNGCP 2015) welcomed about 150 participants from all the Nordic and Baltic countries as well as from Malta, New Zealand, Turkey, Germany, Scotland, Netherlands and Poland.

The main focus of the joint conference was patient care and the role of specialists in pharmacy and healthcare in contributing more efficiently to this process. The conference theme was **Innovative**, **Integrated and Individualised Care**. Described complex approach was emphasized while presenting and discussing the following topics: professional education and training in pharmacy, IT-solutions in healthcare, integration of social and clinical aspects in pharmacy for the wellbeing of patients, evidence based pharmacy practice, contribution of pharmacoepidemiology and pharmaceutical policy to patient-centered care and importance of sustainable development of healthcare systems.

Background and Objectives The goal of the PHAR-QA (*Quality assurance in European pharmacy education and training*) project is the production of a European framework of competences for pharmacy practice. This PHAR-QA framework (<u>www.phar-qa.eu</u>) will be European and consultative *i.e.* it will be used for harmonization - but will not to replace existing national QA systems.

Methods Using the proposals for competences produced by the previous PHARMINE (*Pharmacy education in Europe*; www.pharmine.eu) project, together with those of other sources, the authors produced a list of 68 personal and patient care competencies. Using internet survey tools the stakeholders - European pharmacy community (university department staff and students, community, hospital and industrial pharmacists, as well as pharmacists working in clinical biology and other branches, together with representatives of chambers and associations) - were invited to rank the proposals and add comments.

Results and conclusions Pharmacology and pharmacotherapy together with competences such as "supply of appropriate medicines taking into account dose, correct formulation, concentration, administration route and timing" ranked high. Other topics such as "current knowledge of design, synthesis, isolation, characterisation and biological evaluation of active substances" ranked lower.

Implications for practice In the short term, it is anticipated that this survey will stimulate a productive discussion on pharmacy education and practice by the various stakeholders. In the long term, this framework could serve as a European model framework of competences for pharmacy practice.
